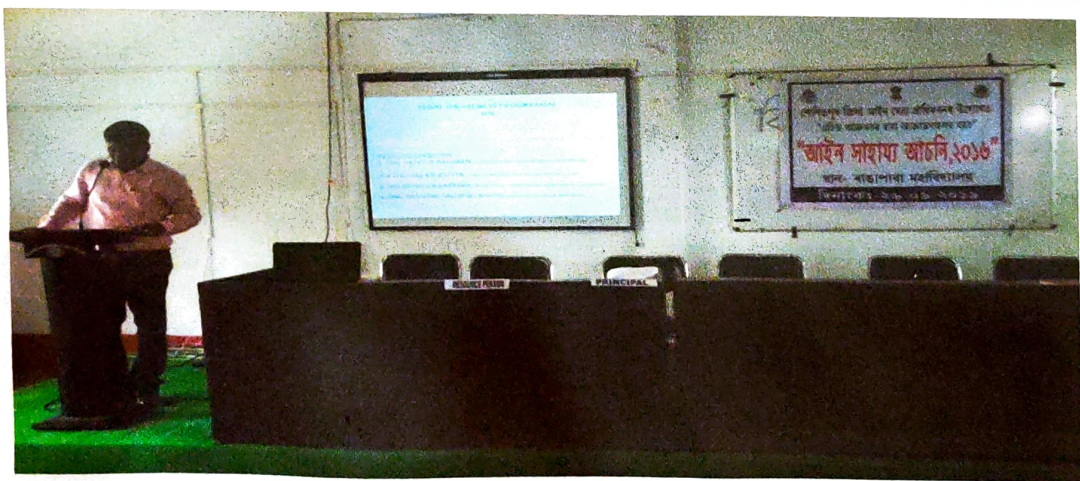

The programme was presided over by Dr. Ranjan Kalita, Principal of the College, who has also given the welcome speech in the programme. Inaugural lecture was given by Prof. Baneswar Talukdar, Vice Principal of the college. Resource person, Md. Sajidur Rahman, in his lecture addressed the students community on the disastrous effect of acid attack . Next, Anjan Kr Dutta, Programme Co-Ordinator, Tezpur Court made his deliberation on the Legal Aid Act, 2016, with explanation of some of its important Clauses. Ms Dipshikha Sarmah, Project Asst. Co- Ordinator, Assam State Legal Services spoke on some of the case histories of acid attack victims in India and their follow up actions under law of the country. Lastly, Md. Sahajan Sakim Quarishi, Para Legal Volunteer, Rangapara given his talk on how people can easily access legal assistance for not only acid- attack cases but also for any injustice issues, in general, under different provisions of District Legal Services Authority.
