



MEMORANDUM OF UNDERSTANDING BETWEEN RANGAPARA COLLEGE AND

MAHAPURUSH SRIMANTA SANKARDEV NAMDHARMA SAMAJ, ASOM ON SPIRITUAL & CULTURAL ACTIVITIES AND ON VAISHNABA LITERATURE

Rangapara College, Rangapara, Sonitpur, Assam, hereinafter referred to as "RC" and Mahapurush Srimanta Sankardev Namdharma Samaj, Asom hereinafter referred to as "MSSNS", hereinafter referred to as "the Party" and jointly referred as "the Parties";

ACKNOWLEDGING that;

- 1. RC is a degree level provincialized educational institution, having its address as Rangapara, Sonitpur, Assam, India, 784505.
- 2. MSSNS is a spiritual and cultural educational institution, having its address as Kaliabor, Nagaon, Assam, India.

DESIRING to; support the cooperation between the Parties in education, spiritual, cultural and vaishnaba literature programs;

PURSUANT to the prevailing laws and regulations, policies and procedures that govern the provincialized colleges in the state of Assam.

HAVE REACHED the following understanding: -

ARTICLE 1 OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to cooperate in spiritual education, yoga and in areas of mutual interest.

ARTICLE 2 SCOPE OF COOPERATION

The Parties agree to implement cooperation programmes including but not limited to:

- a. Undertaking programmes on spiritual, cultural and literary activities at the RC campus.
- b. Faculty and student exchange.
- c. Curriculum development of certificate and diploma courses.
- d. Cooperation during conduct of study tour.
- e. Undertaking joint research and literature study at the faculty and student level.
- f. Any other areas as mutually agreed upon by the Parties





ARTICLE 3 LOCATION OF ACTIVITIES

- 1. The Parties agree to implement the programmes stated in ARTICLE 2 at RC and MSSNS, Kaliabor.
- 2. Any changes to the location of the programmes shall be mutually agreed upon by the Parties.

ARTICLE 4 EXECUTING AGENCIES

To implement this MOU: -

- 1. RC appoints the coordinator, IQAC, RC (herein after referred to as RC Rep).
- 2. MSSNS appoints the Secretary (herein after referred to as MSSNS Rep).

ARTICLE 5 FINANCIAL ARRANGEMENT

- 1. Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
- 2. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme specific arrangement.

ARTICLE 6 INTELLECTUAL PROPERTY RIGHTS

- 1. Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.
- 2. In case of specific arrangements, programmes or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

ARTICLE 7 CONFIDENTIALITY

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MOU, the disclosing Party shall have prior written consent of the other Party.

ARTICLE 8 LIMITATION OF PERSONAL ACTIVITIES

The Parties shall ensure that the personnel engaged in the activities under this MOU shall engage in activities under the framework of this MOU with respect to laws and regulations in the state of Assam and the country of India.

ARTICLE 9 SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultation or negotiation between Parties.

ARTICLE 10 AAMMENDMENT

- 1. This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MOU.
- 2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

ARTICLE 11 ENTRY INTO FORCE, DURATION AND TERMINATION

- 1. This MOU shall enter into force on the date of signing.
- 2. This MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by mutual consent of the Parties.
- 3. Either Party may terminate this MOU at any time by giving written notification to the other Party on its intention to terminate this MOU, six (6) months prior to the date of termination.
- 4. The termination of this MOU shall not affect the completion of any programmes or projects in progress and not completed at the time of termination.
