

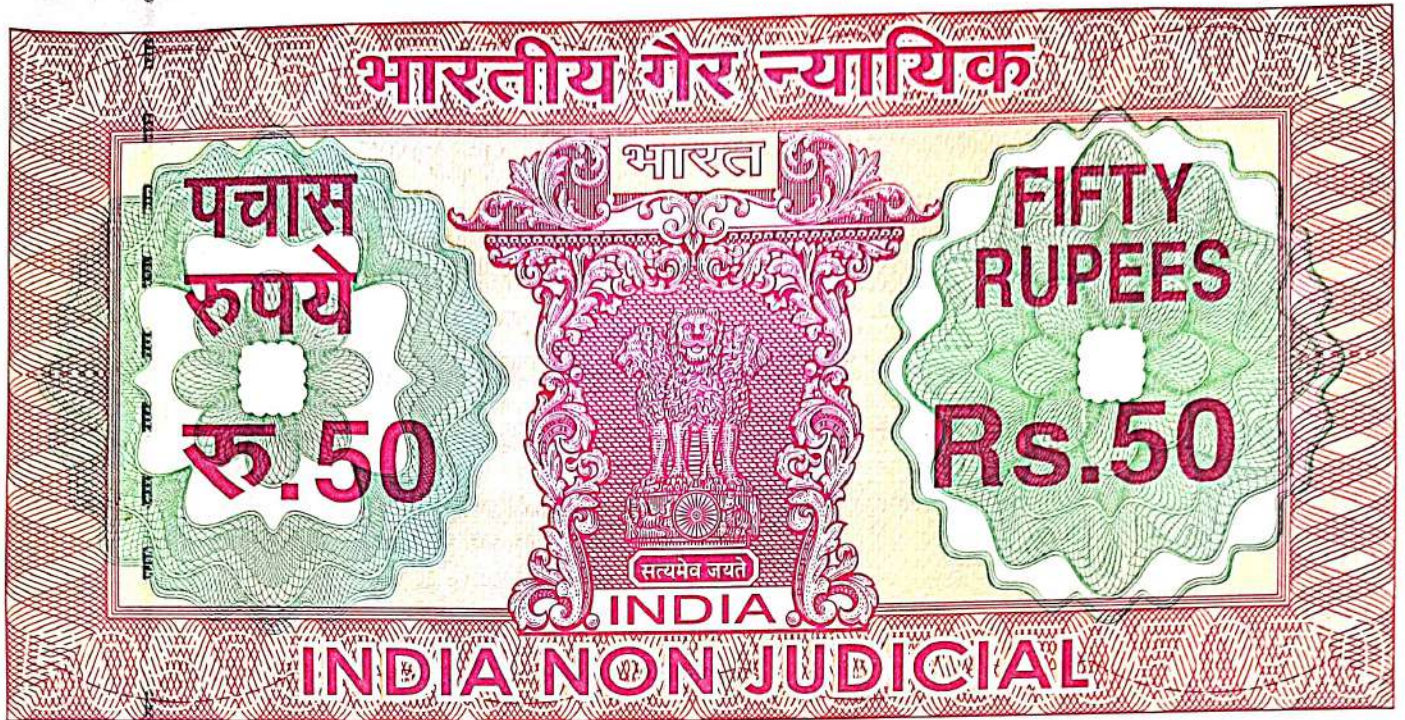

**ARTICLE 1

**ARTICLE 3
LOCATION OF ACTIVITIES**

1. The Parties agree to implement the programmes stated in ARTICLE 2 at RC and JNA.

**ARTICLE 4
EXECUTING AGENCIES**

To implement this MOU: -

1. RC appoints the HoD, Chemistry, RC (herein after referred to as RC Rep).
2. JNA may appoint its employee for performing and communicating with RC. (Herein after referred to as JNA Rep).

**ARTICLE 5
FINANCIAL ARRANGEMENT**

1. Any cooperation under this MOU is subject to the availability of funding sources and approval by college authorities.
2. Any specific project of joint interest will be detailed in an agreement, including financial and programme specific arrangement.

INTELLECTUAL PROPERTY RIGHTS**

1. Each Party shall protect, within its capacity and territory in accordance with the laws and regulations in force in the state of Assam and the country of India.

**ARTICLE 7
CONFIDENTIALITY**

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MOU, the disclosing Party shall have prior written consent of the other Party.

**ARTICLE 8
LIMITATION OF PERSONAL ACTIVITIES**

The Parties shall ensure that the personnel engaged in the activities under this MOU shall engage in activities under the framework of this MOU with respect to laws and regulations in the state of Assam and the country of India.

**ARTICLE 9
SETTLEMENT OF DISPUTES**

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultation or negotiation between Parties.

**ARTICLE 10
AMENDMENT**

1. This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MOU.
2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

**ARTICLE 11
ENTRY INTO FORCE, DURATION AND TERMINATION**

1. This MOU shall enter into force on the date of signing.
2. This MOU shall remain in force for a period of three (3) years and may be extended for another period of three (3) years by mutual consent of the Parties.
3. Either Party may terminate this MOU at any time by giving written notification to the other Party on its intention to terminate this MOU, three (3) months prior to the date of termination.
4. The termination of this MOU shall not affect the completion of any works in progress and not completed at the time of termination.
